Dear Participant/Parent:

I would like to introduce myself. For the past several years I have been the official photographer for the Virginia State Cinderella Pageant and recently the Delaware Tri State Cinderella Pageant. I have also photographed our own State and Preliminary Pageants for New York State.

It is important to understand that if you were to try to photograph your child at the event it would be distracting to the child and a nuisance to the audience. The participant needs to pay attention to not only what they are doing but where they are walking. You want the contestant to be attentive during the interview and to the judges. In addition, trying to catch that special photo you only miss them. You may also, with your camera flash, interfere with my system flash units.

I try to photograph those special moments on stage and will shoot several shoots in sequence. I am unlike any other studio since I am providing you with a DVD of **all on stage pictures** during the event whether it's your child or another parents. Other studios give you choices of around 4 or 5 pictures for \$75.00 to \$100.00.

I will also be available in the morning to photograph portraits of your contestant or your family. There is an additional nominal charge for this.

In order to receive your ordered DVD you agree to the following as part of my copyright release:

- 1) You shall not allow anyone except you or your spouse to use the DVD to print any photos. I request that you honor this request. You may have an adult child use the DVD, however, insure that all the below conditions are met, especially when it comes to printing or emailing any photo.
- 2) You agree not to print or include any photo or digital image in any publication, newspaper, email, blog, personal web site or other media, of individuals not a member or child of your family unless you have the expressed written permission of the parent, or legal guardian of the individual in the photo. This is especially important to avoid any legal action that may be taken against you.
- 3) If the photo is to be used in a commercial setting or print, where compensation is involved, you will require my release and I will expect compensation of \$60.00 for the photo/file used and I will also expect photographer credit. The copyright release does not apply to commercial use.
- 4) You understand that the photos on the DVD must be down loaded to your computer then copied to a CD, in order for any photo print store to print your photos, or, in some cases you can email the photos to the store such as CVS or Wal-Mart. Kindly check with the photo center to determine the media type they require. You may use any software that is able to crop or enhance the photo in order to get the print you want. The file sizes on the DVD will enable you to print photos of at least 8 x 10 or larger.
- 5) Warning: Making a copy of this DVD is in violation of copyright laws. To insure the best quality copies and to keep your cost affordable DO NOT allow anyone to make a copy of this DVD
