AREAS OF COMPETITION – MANDATORY EVENTS (See official rules)

In all areas, girls are judged on confidence, personal appearance, grooming, poise, personality and stage presence. **Cinderella Beauty:** Contestants in the Tot through Miss Divisions model a knee or tea-length party dress. Teen and Woman contestants model a full-length gown.

Casual wear: Contestants model a casual outfit; usually slacks, shorts, jackets, matching sets, NO SWIMSUITS or SPORTSWEAR.

Talent & Tot Personality: Talent is required for the Mini Miss through Woman age divisions. Talent presentations **must not** exceed 2 minutes 30 seconds, and are judged on technical ability, personality, appropriateness, and entertainment value. (The talent should be between 2 min. and 2 min. 30 sec.) Tot Personality, an onstage interview, takes the place of Talent for the Tot division.

Interview: All divisions will have an interview with the judges. Tot through Miss Contestants will be interviewed in groups by a panel of judges. Teen and woman contestants will have individual interviews with a panel of judges, which will last for about 5 minutes.

Photogenic: Contestants are to submit one head & shoulder photograph .This is for the program book and must be a 4 x 6. (A \$25.00 reduction or enlargement fee will be charged if a 4 x 6 is not submitted.) One 8 x 10 is to be submitted for the judges, either color or black & white for Photogenic contest. Contestants are judged on photogenic qualities and personality in the photo.
